Directions are as follows:

- 1. It is preferable to take I-10 or I-12 to Slidell, LA.
- 2. EXIT AT GAUSE BLVD EAST (US-190)
- 3. TAKE GAUSE BLVD E/US-190 TO MILITARY RD.
- 4. TURN LEFT ONTO N. MILITARY RD/LA-1090 AND PROCEED TO ROBERT DR. This is about 3 miles, your will cross over I-10. Robert will be in a dog leg left turn. Entrance to Magnolia Estates will be on the right.
- 5. TURN LEFT ONTO ROBERT DR. ROBERT DR BECOMES CUNNINGHAM DR. AS IT TURNS LEFT AND PARALLELS THE INTERSTATE, AND PROCEED TO MAPLEWOOD LN.
- 6. TURN LEFT ONTO MAPLEWOOD LN.
- 7. TURN RIGHT ONTO DOVE CT.
- 8. 101 DOVE CT IS ON THE RIGHT (on the corner)
