Getting ready for the 2006 NCRS Judging Retreat in Dallas

For those who are planning to attend the retreat this year or even in a following year, I think I can offer some suggestions on preparations. Last year I attended the judging retreat in Dallas and basically showed up without any preparation. This was certainly not a problem as the organizers thought of most things that were needed but since I plan on going again, I thought I would offer some suggestions and some advice on what to expect.

Last year there were two sessions going on simultaneously. On the first day, the attendees were broken up into two groups one of which attended classroom sessions while the other group participated in a simulated judging event with very experienced NCRS judges acting as owners and others acting as coaches. The next day, the groups switched so all were exposed to the whole venue.

The classroom session was a series of lectures on NCRS procedures and judging standards on everything from operations to a very interesting one on paint. I found this to be very informative and a way to hear what would take you years on the judging field to pick up.

The simulated judging event was an abbreviated one day affair where teams assigned to different car classes judged a car through all of the NCRS areas such as operation, chassis, interior, etc. During this a couple of experienced judges acted as coaches showing each team what to look for and how to deduct points. One of the experienced judges acted as the car owner and did a credible job of whining at every call. I really enjoyed this as it was very well thought out. As I read the literature for the 2006 retreat, it seems that they are planning on having four sessions overlapped by an additional day so make sure your plans have enough time for all events since you really don't want to miss any.

I would also suggest that if you have the judging manuals and judging guide for the class of cars you have requested they should be brought along. There are never enough manuals during the judging event. I would also suggest a small flashlight and a small adjustable mirror. A magnifying glass would also be handy for reading the small numbers for those of us who need such things. Last year the attendees were provided with notebooks and pens and I assume this will be provided again but just in case, a small notebook and pen would be a safe thing to bring along. Some of the classroom lectures deserve noting for future use.

And lastly, expect a great time with lots of folks interested in the cars, on which we spend so much time, who have great stories. The after hours get-togethers in the hotel bars and restaurants are very enjoyable and a great place to meet the NCRS folks from all over the country. Hope to see some of you there. Jim Boudreaux
